INTRODUCTION

Paqam is a First Nations community whose government organization services 374 Band Members and other aboriginal peoples within the Ktunaxa Nation. Geographically, the community is located 8 km north of Cranbrook in the East Kootenay region of British Columbia. The community of Paqam wishes to continue the traditional land practice of prescribe burning on Paqam lands. Objectives of the project include ecosystem enhancement by reducing dense trees, revitalizing herbs and ungulate forage on the land base and continuing cultural practice for Paqamnik.

?aqam's Lands and Natural Resource Department is seeking quotes for assistance from a Qualified Environmental Professional in Species at Risk (SAR) surveys and, if necessary, applying for a SAR Permit with Environment Climate Change Canada (ECCC). Anticipated work activities include SAR surveys on Kootenay IR #1 and a report including how anticipated prescribed burn activities may impact the listed SAR and developing appropriate mitigation measures as needed.

A service agreement will be issued to the successful bidder in compliance with the terms, specifications, and provisions in the submitted quote, which must include the provision of skilled labor, transportation, supplies, and incidentals. Suppliers will be responsible for all their own equipment and transportation.

BACKGROUND

The study area will be conducted primarily within Kootenay IR #1. There are two planned burn units within ?aqam's Lands "Parcel A" (168 ha) and the "Lot 79" (137 ha) units as seen in **Appendix B and C**. Anticipated safety practices should be outlined by contractors, and all safety practices and standards with required PPE should be met as per WorkSafe BC. The awarded contractor will be responsible for all their own equipment. Contractors will have access to all existing data and reports on SAR on ?aqam's Lands to the awarded bidder. The contractor will assist in all necessary pre-work and prescribe burn prescriptions to ensure SAR mitigations and best management practices are being followed.

Please note the prescribe burn area's may have minor changes once the contract is awarded

REGULATORY APPROVALS

- The Contractor is responsible for complying with all Federal, Provincial, and Municipal legal regulatory requirements and all applicable environmental legislation.
- The Contractor shall comply with the province of British Columbia's requirements for spill prevention and response.
- The Contractor must demonstrate their qualifications as a Qualified Environmental Professional (QEP) and membership with BC's College of Applied Biology or an equivalent organization.

INSURANCE

- The Contractor shall carry Comprehensive General Liability Insurance in the amount of a minimum of \$5M for each and every occurrence and Workers Compensation Insurance in accordance with the requirements of the British Columbia *Workers Compensation Act*
- If awarded the contract, each of these will need to be submitted to the ?aqam Lands Department.

SCHEDULE

- ?aqam will award the contract resulting from this Request for Quote (RFQ) to the responsible Contractor whose offer conforming to the RFQ will be most advantageous to ?aqam, based on price competitiveness, qualifications, and previous work with ?aqam or other Ktunaxa First Nations.
- Proper PPE and survey equipment for all field work.
- Follow all WorkSafe BC work standards to complete all required field work.

- Experience working with ?aqamnik, Ktunaxa, or of other First Nations on related projects.
- Demonstration of qualifications and experience of company/contractors working within the southern rocky mountain trench with SAR surveys and reporting.
- Cost competitiveness.
- Inclusion of all safety and regulatory requirements to complete the scope of work.


