When: Sunday, April 9, 2023 Location: St. Eugene Church


The church doors will be opened at 1:00 P.M and the Mass will commence at 1:30 P.M



Department Information and Upcoming Events



The Economic & Investment Sector have been working on the Community Connectivity Initiative (Free Internet) that has been supported by the Sector Council. In order to begin the process to be able to ensure Ktunaxanintik on reserve have accessibility to the free internet, we need to inspect the fiber infrastructure at each home. We are hoping to contract DHC Communications to inspect and make repairs where necessary at no expense to the Ktunaxa First Nation.

When?

March and April 2023.

Where?

We would like to check all the fiber optic network that goes to each household on the reserve.

DHC will need external access to each house property to check the fiber connection to your home. DHC will NOT require access to the interior of the homes.

Why?

This is an important task because the Community Connectivity Initiative has been passed by the Economic Sector Council, so if any household chooses FREE internet, this fiber network needs to be 100% inspected, maintained and repaired to have reliable and fast internet.

What's next?

Once the fiber network is verified and any customers have signed up for FREE internet, a FlexiNET representative will need access to the interior of the client's home for connecting the equipment to deliver the internet services.

What if I don't want free internet?

Even if you do not want FREE internet at the moment, you may want FREE in the future, so repairing and maintaining this fiber to your home is beneficial.

Spring Burning Tips

Are you planning to do any burning on your property this spring? Using a burn barrel? Burning off brush/wood piles? Stubble/grass burning?

If you are, then:

Think safety first and always err on the side of caution!

- Burn only in ideal conditions (i.e. no wind and good venting so that smoke rises and clears quickly)
- Do not burn when Provincial fire bans or restrictions are in place. Check online at: http://bcfireinfo.for.gov.bc.ca/hprScripts/WildfireNews/Bans.asp or call, 1-888-336-7378 Members may wish to secure a burn permit with the Province of British Columbia. This can be done by calling 1-888-797-1717 and providing basic information over the phone. Avoid burning in the heat of the day
- Ensure that you have adequate supervision, manpower, equipment and water nearby
- Use features like roads, bare soil and watercourses to help establish fireguards/perimeters
- Always burn from the outside perimeter and against the wind.
- Never ever leave a burn unattended
- After the burn is complete, continue to patrol until all flames and hotspots are completely extinguished
- Pile and re-pile woody debris if needed and establish a fireguard (down to mineral soil) around any burn barrels or piles
- Call Band Administration (Lands Department) before you plan to burn to let them know when, where and what you will be burning.

And most importantly, if your fire becomes out of control immediately call 911!

Airport Pasture Prescribed Burn

?aqam Lands department, in conjunction with the BC Wildfire Service, are planning to conduct a 1,240 hectare prescribed burn between April 1- April 30, 2023, weather and burning conditions permitting. The prescribed burn unit is immediately East of the Canadian Rockies International Airport and extends East to Mission Road.





The prescribed burn is being conducted for ecosystem enhancement purposes- to improve biodiversity while reducing wildfire risk. This project will improve habitat for several species including Elk (ki+qa+), Deer (¢upqa), Flammulated Owl (kupi), Lewis' Woodpecker (ka¢ka¢) and Little Brown Bat (?a·kłum).

To accommodate sensitive wildlife species the burn will not take place after May 1st. Over the likely two-day ignition period, area residents can expect to experience periods of smoke. However, the burn will be conducted under weather conditions that will minimize the impacts and duration of smoke. Public safety is paramount so access to the burn unit will be limited until the area can be assessed for danger trees and hot spots.

First Nations Drinking Water Settlement Claims

Are you aware that you may be eligible for compensation under the First Nations Drinking Water Class Action Settlement?

This settlement applies to individual members of First Nations who lived on an Impacted First Nation, that was under a long-term drinking water advisory (boil water advisory, do not consume advisory, or do not use advisory) that lasted one year or longer anytime during November 20, 1995 to June 20, 2021. ?aqam, among others, is an Impacted First Nation under this Claim. The deadline to submit a claim has been extended to March 7, 2024.
