ʔAQ'AM Education Jurisdiction Ratification Vote

TAKE NOTICE that a Ratification Vote shall be held under the ʔAq'am Education Jurisdiction Ratification Process to determine if Eligible Voters approve the Canada-First Nation Education Jurisdiction Agreement Between Her Majesty the Queen in Right of Canada and ʔAq'am, and the Education Jurisdiction.

The following question will be asked of the Eligible Voters of ʔAq'am by ballot:

As an Eligible Voter of ʔAQ'AM:

Do you approve:

“The Canada-First Nation Education Jurisdiction Agreement, dated April 20, 2021; and the ʔAq'am Education Law-Making Protocol?”

(Voters will be able to vote “YES” or “NO”)

Eligible Voters will be able to vote in person, by mail, or electronically. You may only cast one ballot.

Electronic Voting will be available from **9:00 am on November 2, 2021** until **8:00 pm on December 2, 2021**. Those voters wishing to vote electronically may do so by visiting the link below and following the instructions provided:

MAIL-IN BALLOTS

The Ratification Officer will automatically send mail-in ballot voting packages to all voters for whom a residential mailing address is known and provide a mail-in ballot package to each Voter who so requests. Please contact the Ratification Officer (support@onefeather.ca) to request your package if you have not received yours by November 10, 2021.

VOTING ELIGIBILITY

All ?Aq'am Members that are 18 years or older by the date the polls close are eligible to vote. You have the option to vote in person during the times listed below, by mail-in ballot, or electronically. Please bring your status card or other photo I.D. if voting in person to cast your vote at the polling station.

It is the responsibility of each eligible voting member of ?Aq'am to ensure that their mailing address and email address are current with Membership. The Membership clerk will share the membership information with the Ratification Officer, who will generate the Voters' List.

Electronic copies of the Ratification Process, and all related information, are available to all eligible voters at the election website.
